

#### INFORMATION CLAUSE

### ON THE PROCESSING OF PERSONAL DATA BY LS TECHNICS SP. Z O.O.

In accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons in regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 /EC, General Data Protection Regulation, hereinafter referred to as "GDPR", we inform that:

### 1. Administrator of personal data

The controller of your personal data is LS Technics sp. z o.o. with headquarters in Pyrzowice (42-625), at Centralna 5 Street, entered in the register of entrepreneurs kept by the District Court in Gliwice, X<sup>th</sup> Commercial Division of the National Court Register under number 0000152229, share capital in the amount of: PLN 45 813 840,00, NIP: 645-10-02-139 (hereinafter: the "Company").

### 2. Data Protection Officer

The Company has appointed a Data Protection Officer, who can be contacted at the following e-mail address: iod@lst.aero or correspondence address: LS Technics sp. z oo, ul. Centralna 5, 42-625 Pyrzowice.

### 3. Purposes and lawful basis for processing

The Company will process your personal data:

- 1) for the purpose and scope necessary to register a user account enabling the use of the platform, based on your consent, in accordance with art. 6 sec. 1 lit. a GDPR;
- 2) in order to possibly establish, investigate or defend against claims, in accordance with art. 6 sec. 1 lit. f GDPR.

### 4. Retention period

Your personal data will be processed for the period of using the platform and for the period in which claims related to this use may be disclosed, taking into account the limitation periods for claims specified in generally applicable provisions of law.

## 5. Categories of personal data

The Company processes your personal data in the following scope: name, surname, e-mail address, no. phone, company name.

## 6. Odbiorcy danych

Your personal data may be made available to entities authorized on the basis of legal regulations, employees/associates of the Company, as well as entities to which the Company entrusted data processing on the basis of concluded data processing agreement, such as IT system and IT service providers, entities providing legal services - to the extent as necessary for the provision of these services.

## 7. Rights of data subjects

According to the GDPR, you are entitled to:

1) the right to withdraw your consent at any time without affecting the lawfulness of processing based on consent before its withdrawal.



- 2) the right to request the Company to access personal data and receive a copy of it, in accordance with art. 15 GDPR,
- 3) the right to request the rectification (correction) of personal data in the cases referred to in art. 16 GDPR,
- 4) the right to request the deletion of personal data in the cases specified in art. 17 GDPR,
- 5) the right to request the restriction of the processing of personal data in the cases specified in art. 18 GDPR,
- 6) right to data portability, in the cases specified in art. 20 GDPR,
- 7) the right to object to the processing of your personal data in the cases specified in art. 21 GDPR, and
- 8) the right to lodge a complaint to the President of the Personal Data Protection Office, if you feel that the processing of personal data violates the provisions of the GDPR.

## 8. Provision of personal data

Providing your personal data is voluntary, however, failure to provide the data will prevent you from registering your user account and using the platform.

# 9. Automated decision making

Your data will not be subject to automated decision making in accordance with art. 22 GDPR, including profiling.
